The Board of Selectmen and the Finance Committee reviewed the FY2027 Cemetery Commission budget submission. The Cemetery Commission requested that its budget be level-funded.

FY26 VOTED: \$18,500

FY27 REQUESTED: \$18,500

2. Conservation Commission

The Board of Selectmen and the Finance Committee reviewed the FY2027 Conservation Commission budget submission. The Conservation Commission has requested an increase in its budget of \$790. The overall budget requested increased by 42.02%.

The overall budget requested increased by 0.87%.

5. Board of Assessors

The Board of Selectmen and the Finance Committee reviewed the FY2027 Assessors budget submission. The Board of Assessors has submitted to level fund the operations and reval budget lines and increase the Assessors Clerk wages, which is expected annually. The overall budget requested increased by 0.29%.

FY26 VOTED: \$60,785
FY27 REQUESTED: \$60,962

Assessors Chair Rick Williams briefly discussed that FY2027 is an interim update year and that the next reval is in FY2028.

6. Board of Health

The Board of Selectmen and the Finance Committee reviewed the FY2027 Board of Health budget submission. The Board of Health has assessment increases to the refuse garden operations (hauling fees), mosquito control district, and FRCOG health services. The Board of Health Clerk, Town Nurse, and Refuse Garden attendant have an annual expected increase to their wages. The overall budget requested increased by 2.08%.


